### Entry Information:

It is the exhibitor's responsibility to contact the Entry Clerk to confirm receipt of online entries. Neither the Entry Clerk nor Fort Worth Cat Club will be responsible for entries lost due to communication errors. Per show rule 6.21, all entries must be accompanied by proper entry fees. Entries must be paid in full within 10 days of receipt or prior to the show, whichever is first.

No substitutions will be accepted after the closing date. No refunds made once your entry is received or for failure to bench.

Working club members: \$45/entry.

**Liability:** Fort Worth Cat Club will take reasonable care to safeguard entries and the property of exhibitors. Neither the Club nor Burleson Event Center will be liable for any loss, damage or injury. Each exhibitor will be responsible for any damages they cause to the property.



### Cages and Supplies:

Exhibitors are responsible for providing their own benching enclosures. A standard single benching space is 22"x22" (Show Rule 5.01j); a double space is 22"x45". If you do not have an enclosure, a "pop up" is available to purchase at the show for \$20.

Use of any enclosure requires payment of "extra half space" fee for first entry. Fort Worth Cat Club will waive that fee for subsequent odd-numbered entries (3rd, 5th, etc.).

Litter will be provided; bring your own litter pans, cat food and cat dishes.

**NOTE: Per show rule 10.05, No more than two kittens or one cat may be benched in a single space whether entered for exhibition or competition or benched for sale.**

### Show Rules:

This is a CFA licensed show and all CFA show rules will be enforced. A copy of the show rules may be purchased from CFA. All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. The Club reserves the right to add or substitute judges not named in the show flier should it become necessary.

### Health Information:

This is a non-vetted show. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, caliciviruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All entries must be free of fleas, ear mites, fungus, or any contagious or infectious illness. Claws of all entries must be clipped prior to benching. Declawed cats are not permitted in the show hall. No kittens under the age of 4 months will be permitted in the show hall.
